## Who we are



The Scottish Parliament Pàrlamaid na h-Alba We are the **Health**, **Social Care** and **Sport Committee**.



A committee is a small group of people who are Members of the Scottish Parliament, also called MSPs.



The Scottish people decide who is an MSP by voting for them in elections.




The Scottish Parliament makes **laws** in Scotland. **Laws** are rules that tell people what they can or cannot do.

# What this booklet is about



This booklet is about a new **bill**. A **bill** is a document that could become a law.



The Bill is called the Abortion Services (Safe Access Zones) (Scotland) Bill.

The Bill will become part of the law in Scotland if the MSPs agree with it.

# What the Bill is about



The Bill is about making **safe access zones** around places where **abortion services** happen.




A **safe access zone** is an area that is made safe for people to enter and use.



An **abortion** is a medical process to end a pregnancy so that a baby is not born.



Abortion services are places where abortions are done, like hospitals. In the Bill, these places are called **protected premises**.



In the Bill, safe access zones for abortion services include

- the protected premises.
- outside areas around the protected premises, like car parks, pathways or bus stops.
- any other **public land** that is in an area of 200 metres around the protected premises.



**Public land** means an outdoor area the public is allowed to use.





The Bill says it will be an **offence** for people in a safe access zone to behave in a way that might

- make someone feel **intimidated** or **harassed**.
- stop someone getting an abortion.


An **offence** is a crime that can be punished by law.











Harassed means someone is doing things that make you feel scared or upset.

If you are being intimidated or harassed when you use abortion services, it might mean people

- hold **anti-abortion** signs.
- protest about abortions.
- block the way into protected premises.

Anti-abortion means you do not agree with abortions.

**Protest** means show in public that you do not agree with something to try and make change happen.





People who are **convicted** of an offence will have to pay a **fine**.



**Convicted** means a **court** decides you are guilty because you have broken the law.



A **court** is an official place where people meet to make decisions about offences.



A **fine** is when you have to pay money because you have done something wrong.



The fine for an offence might be up to  $\pounds 10,000$ . If the offence was very bad, the fine might be more.



The Bill also says it will be an offence for people who are less than 200 metres from a protected premises but **not** on public land to behave in a way that might make someone feel intimidated or harassed.



This might include

- holding anti-abortion signs from a place that can be seen in the safe access zone.
- using a loudspeaker to protest in a way that can be heard in a safe access zone.

# What the Bill is not about



The Bill is not about abortion law in Scotland.



The Bill does not say there should be changes to abortion law in Scotland.



The Bill is not about deciding if abortion services should be **legal** or not.




Legal means allowed by law.
